4. Kiyoshi Graves and/or Lanny Kusaka may present a zone variance to construct, use, and maintain an ATM and Canopy in the P-1 Zone in conjunction with an existing shopping center in the C2-1 and P-1 Zone at **14671 W. Rinaldi Street.** (east of Laurel Canyon Blvd.)
5. Greg Brendel may present a zone variance to construct, use, and maintain a private charter school on a 7.5 acre site, that would accommodate 1250 students, with a gym, performing arts center, kitchen, eating areas, outdoor recreation, approx. 50 classrooms., labs, and school administration space at **13361 Glenoaks Boulevard.** (at intersection of Drell St.)
6. Planning Associates, Inc. representing Cascades Project Owner, LLC may present zone variance to construct 362 dwelling units changing previously approved 280 condo units to apartments Also allow a height of 45' for the apartments in lieu of the required 35'. Providing code required parking for apartment as opposed to Advisory Agency Parking Policy for condos of 2.5 spaces per unit. Use of proposed Lots 12 and 13 for residential in lieu of "park", and "club/commercial" uses; and use of Lot 13 for residential in lieu of golf course or related uses. At **16325 Silver Oaks Drive.** (at intersection with Balboa Blvd.)
