Minutes of the SYLMAR NEIGHBORHOOD COUNCIL (SNC) GENERAL BOARD MEETING Thursday, January 22, 2015

at Sylmar High School, Spartan Hall Auditorium, 13050 Borden Ave., Sylmar, CA 91342

SNC (and all other) Meeting Minutes are a summary, not an exact, verbatim, word-for-word transcript of what was said at a Meeting. The only two exceptions to this are the Motions and quotes, which are words that have quotation marks ("") at the beginning and ending of a word or words. The Minutes were not, are not and are never meant to be a comprehensive record of what was said about an issue or project.

1. Call to Order and Pledge of Allegiance

President Ann Job called the meeting to order at 6:33 p.m. Derek Martin led the Pledge of Allegiance.

2. <u>Roll Call</u>

Roll Call was taken by Ms. Job.

Twelve of the 20 Board Members were present at the beginning of the Meeting: Kathy Bloom, Peggy Courtney, Laurie Fadness, Lucille Floresta, Kathy Grubert, Ann Job, Derek Martin, Jackie Mata, Patricia Rau, Christian Rubalcava, Maria Silva, and Diane Valencia.

Two arrived later: Cheri Blose and Brenda Resendis, resulting in 14 board members present until the recess. Peggy Courtney left at Recess, resulting in 13 board members present for the remainder of the meeting. **Six** Board Members were absent: Carlos Gonzalez, Carlos Lara, Jeh Meher, Chardell Powell, Chris Shows and Roy Smith.

The SNC quorum (the minimum number of Board Members needing to be present to take binding votes on Agendized Items) is 11 (see http://empowerla.org/wp-content/uploads/2012/05/Sylmar-NC-Bylaws.pdf), so the Board could take such votes. Twenty of the 21 Board Seats were filled. One Board Seat (At Large) was vacant. Also attending: 38 Stakeholders and Guests.

3. <u>Housekeeping, Speaker Cards and Timekeeper</u> – Ms. Valencia explained this.

4. Welcome and Announcements by Board Meeting facility Host.

Meeting Host Derek Martin of Sylmar High School welcomed everyone and reported that "427 seniors are on track to graduate."

5. Approval of Minutes of the November 20, 2014 General Board Meeting

MOTION (by Ms. Valencia, seconded by Ms. Rau): The Sylmar Neighborhood Council approves the Minutes of its November, 2014 General Board Meeting as written.

MOTION PASSED by reverse voting of the 12 board members present with 10 in favor ("Yes" or "Aye") (Bloom, Courtney, Fadness, Floresta, Grubert, Job, Martin, Rau, Rubalcava, and Silva); none opposed; 2 abstained due to not having been at Special Board Meeting in November (Mata and Valencia).

Board Member Cheri Blose arrived at this time (6:39) making 13 Board Members present (the SNC quorum is 11).

6. Approval of Minutes of the December 27, 2014 Special Board Meeting

MOTION (by Ms. Rau, seconded by Ms. Grubert): The Sylmar Neighborhood Council approves the Minutes of its December 27, 2014 Special Board Meeting as written.

MOTION PASSED by a roll call vote of the 13 eligible voters present with 9 in favor ("Yes" or "Aye") (Bloom, Blose, Courtney, Floresta, Grubert, Job, Mata, Rau, and Valencia); none opposed; 4 abstained due to not having been at Special Board Meeting in December (Fadness, Martin, Rubalcava, and Silva.)

7. Public Official and Community Representative announcements and presentations.

Alonzo Menchaca, LAPD Mission Division reported that Mission Division crime is "down 8%" and that Sylmar crime is "around 13% down," but there is still a big problem with stolen cars. "The Mission Division will participate in a pilot program" in which Officers will wear body cameras. He described policies and procedures will be created. They are not yet wearing the cameras. There will be a public comment period; no dates are set. Officer Menchaca described the effects of Proposition 47 that voters passed. Around five medical marijuana shops are in Sylmar; "one was grandfathered in; the others are supposed to be shut down." He added that "if we can hear music over 150 feet . . . we can issue a citation and shut them down." Also, many drug users "don't want the help."

Board Member Brenda Resendis arrived at this time (7:00) making 14 Board Members present (the SNC quorum is 11).

State 18th District Senator Bob Hertzberg (818-901-5588; http://sd18.senate.ca.gov), said there are one million people in this State Senate District. He encouraged contacting him for help. Soon Senator Hertzberg will announce an Open House.

Ricardo Benitez, Field Representative for State 39th District Assemblymember Patty Lopez (818-504-3911) introduced himself.

7a. Questions / Comments from the Public – There were none at this time.

8. Board Member community announcements.

Ms. Fadness reminded that the SNC needs help finding office space.

9. <u>Secretary's Report</u>

10. <u>Committee Reports</u>

Equestrian -- Ms. Blose reported that the Committee is planning events.

<u>Government Affairs & City Services</u> – Mr. Rubalcava reported that the City Bureau of Street Services will do more street repairs in February. He encouraged contacting him at Christian.Rubalcava@SylmarNC.org with street repair requests.

Budget -- Ms. Rau said the next Committee Meeting will be January 27th at 6:30 at Concordia.

<u>Executive</u> – Ms. Valencia described how the SNC Office was lost "early last year" and that "we were notified in December that we had to move by the end of the month." The SNC Special Board Meeting in late December "voted to move all of our office equipment" into a storage facility (Nova). She explained phone service is costing \$4 per month and that the Executive Committee automatically receives phone messages. She encouraged Board Members to complete Ethics Training and sign the Code of Conduct.

Outreach – There was no report.

<u>Bylaws</u> -- Mr. Smith was not present and there was no report at this time. <u>Planning & Land Use</u> -- Ms. Blose deferred to below land use Items. <u>Emergency Preparedness & Public Safety</u> – Mr. Powell was not present and there was no report at this time. <u>Ad Hoc Sediment Removal</u> – Ms. Grubert deferred to below Item #21. <u>Underserved Stakeholders</u> – Ms. Courtney deferred to below Item #13.

11. Reports by Liaisons to the City

 Imelda Padilla, a LAANE (L.A. Alliance for a New Economy; 213-381-5611; LARaiseTheWage.org) Organizer, distributed fliers about their January 30th rally "to raise the minimum wage."
 Stakeholder Nick Krall announced the Sylmar "Relay for Life" Cancer Walk-a-Thon 24-hour event [www.RelayForLife.org/SylmarCA] from Saturday, May 17th at 9:00 a.m. through Sunday, May 18th at 9:00 a.m. at Olive Vista Middle School [14600 Tyler St.] from 9:00 a.m. Saturday, May 16 through 9:00 a.m. Sunday, May 17. He said they will "be asking for \$1,000" in funds; the SNC logo would be on all materials.
 A Youth Speak Collective (818.890.8033; www.YouthSpeakCollective.org;

Info@YouthSpeakCollective.org) representative distributed brochures and described their programs. 4) Ray Verches, SoCal Gas Company Advanced Meter Project representative, distributed information and again reviewed the project and reported that "within the next thirty days" they will mail letters about the meter switch. He displayed a sample meter and reported that "we're about halfway through it" and "we'll be able to read your gas on a daily basis." He said the output is "65 megahertz . . . one million times less than your cell phone." The cost increase is expected to be "\$2 per month." An "opt out" program is being developed and may cost around \$10 per month. He said, "you'll receive a letter" about upcoming home and business visits. He reminded everyone to put pets inside if SoCal Gas is visiting; "you need to notify" them if you have a pet or other reason that the meter would be inaccessible.
