3. Housekeeping: Speaker Cards, Recording, and Timekeeper. Welcome from Facility Host. Assemblymember Luz Rivas was sworn in on August 2018 and voted on 100s of bills. The Assemblymember was asked by stakeholders if she had read all the bills that she had voted on. She stated that she had staff help with the bills she voted on. The Assemblymember had sponsored AB 263 to honor Caltrans workers that had fallen on the job. The ceremony will be held next Thursday to honor the fallen worker in Sylmar. The purpose of the bill was also intended to raise awareness for highway worker safety. The Assemblymember co-sponsored a freeway beautification event with SVANC to clean up an off-ramp. While participating in the event on the off-ramp, stakeholders learned to understand the issues facing workers of Caltrans. Caltrans has promoted a new supervisor for the district. The community is now getting the response for the freeway they need. Homeless people are wandering the freeway which is dangerous for the homeless and the drivers. CHP is working with the homeless to get services provided to them so they will not be living on adjacent property of the freeway. The SNC went to the office to discuss a property on Roxford where a state property needs to be beautified and that clean-up project will start this Friday. Additional plans will be worked on with the Council Office to beautify the area. The Assemblymember's Office had requested the help of the community for new ideas from the community to plan projects between January and February 2019. Questions were asked from the community.

Mr. K. Cabrera-Miller joined the meeting at 6:36PM. Ms. Floresta joined the meeting at 6:42PM

Senator Bob Hertzberg spoke about the end of the Senate session on August 30, 2018 and how he looks at the top line and bottom line of the budget. The tax structure is very volatile and the state charter requires only 1% of reserves, but the Governor has fought to maintain two rainy day funds. The Senator discussed how he is very concerned about a possible down turn in the economy, but the State currently has \$19 Billion in reserves. The Senator is focusing on two issues; the homeless issue that is impacting and how that crisis impacts the community. Recently, \$85 Million was sent from the State to the City of Los Angeles for temporary housing. The second plan is to work with the CEA to grant \$3000 per household for house bolting. The Senator thinks that Storm water capture SB1 if passed, we will all be screwed. Another priority on his agenda is to fight for local transportation needs in the Valley. Money is currently being spent on large freeway projects and not local Metro transportation. The Senator wants all of us to fight for the SFV. The Senator took question from the community.
