- **8.No discussion** was held regarding the possible approval of funds for Sylmar High School Baseball Team to support youth and community school as the Coach was not present. Postponed.
- **9.Motion was made** regading the approval of funds for promotional materials and refreshments for the Pacoima Reservoir Sediment Removal Town Hall event to be held once the DWP announces the Scoping Meeting. Kathy Grubert, chair of Ad Hoc committee on Sediment Removal, is looking for co-sponsors to cover cost of speakers and notification of Sylmar. 1st and 2nd made by unknown. Passed unanimously.
- **10. Discussion** regarding the Stakeholder Survey and protocols followed. Patti Rau volunteered to enter info into site so that eblast could take place.
- 11. Committee Member Comments on subject matters within the Committee's jurisdiction. There were no comments.
