We desire to express community input received about the proposed development at 14971 Foothill Blvd in Sylmar. This development is planned on the NE corner of Foothill and Roxford and occupy 31,894.2 Sq. Ft. The developer utilizing AB 2345 by providing 12 Very Low-Income Affordable Units.

As proposed:

132 apartments and 1,337 sf. for two retail spaces. 80 units allowed.

143 vehicle parking spaces. 196 Required

224 bicycle parking spaces in lieu of 56 parking spaces.

5 stories at 61' tall. C2 zone allows 45'

Floor Area Coverage Ratio of 2.79:1. C2 zone allows FAR of 1.5:1

Density bonus of 65%

An overwhelming majority of residents expressed their opposition to this development due to its location where there is limited street parking, horse trails, mountain views and adjoining single family homes. The scale of the development is out of touch with the Community Plan and neighborhood. Making use of AB2345 the development does not adequality address project impacts for height, parking, and density. Allowing this development will cause negative impacts to the surrounding community, business and mountain access.

• Many units will be rented and occupied by 2 or more adults that have 2 or more cars. Street parking is limited and will push renters further into surrounding areas to find parking. The need to find parking will impact the surrounding residential neighborhoods.

Note: the development is at the corner of a major freeway intersection with parking restrictions currently on Roxford from Foothill to Olive View Medical Center. There are also parking restriction along Foothill leading up to the intersection with Roxford. There are maybe 1 or 2 allowed curb spaces adjacent to the development


- Retail use of the planned space will have customers unable to find parking anywhere close thereby making these retail spaces undesirable with little likely hood of being used as community retail.
- Equestrian use of the designated trails fronting two sides of this development requires
 maintaining a wide dirt path thereby limiting sidewalk along the new development. More
 vehicles crossing the trail to go in-&-out of the parking structure will put Equestrians at higher
 risk.
- The development height will shade two existing single-family homes to the east for most of the afternoon and glare from apartment windows will reflect into their lots the morning. The height also blocks mountain views enjoyed by the community in this area. This is one of the reasons there is a height limit of 45' on the subject property.

For the reasons stated above the Sylmar Neighborhood Council opposes this development as the use of AB2345 at this location is deemed incompatible with equestrian trails, parking and mountain views.



The Sylmar Planning and Land Use Committee on December 8th, 2021 held a public meeting on the above reference project. This project is located between Herrick and Bradley Avenues and close to the intersection of Norris Avenue. This application is for a proposed addition of 743 square feet to a legal non-conforming single-family dwelling unit.

The existing home of 2,738 square feet was built with a 5' side-yard set-back and detached garage of 1,200 square feet with a 3' side-yard set-back on a lot of 34,5684 square feet. The addition is on the other side of the home and requires the lot be in conformance with current standards of 10' side-yard set-back. The Sylmar Planning and Land Use Committee on December 8th, 2021 and January 12th, 2022 held public meetings on the above reference project. Background: This is an existing vacant restaurant with a new operator requesting changes to allow enclosing front patio, renewal of live entertainment permit, addition of 500 square foot patio at rear of building for dining, as well as addition of dance floor to center area of restaurant and extending the parking area on currently vacant land at rear. The property is located in an Equine District Overlay and has single family homes on 3 sides, with commercial uses on the 4th side towards Polk Street.

Various stake holders expressed concern about noise, lighting, parking security and restaurant becoming a night club. Below are recommendations to mitigate these concerns:

- Restrict hours of live entertainment including loud music and karaoke to 3 days per week, Friday Saturday and Sunday until 12:30am.
- Building entries and exits to be designed to capture noise such as creating a vestibule with a second set of doors so as to prevent noise from escaping the building and into the adjacent community. This would include doors leading to outside patios.
- Limit operating hours Monday thru Thursday until 10pm.
- A maximum of 3 outside events per year, on either Friday, Saturday or Sunday and ending by 12:30am.
- Provide parking lot security during entertainment hours and events.
- Close off parking area when restaurant is not open to prevent unauthorized use.
- Shield outside lighting from adjoining properties.
- Any further Zoning Administrator mitigations that would help reduce noise impacts as well as to ensure the primary business is a restaurant that does not evolve into a night club.

Provided the above conditions are accepted by the applicant along with other mitigations and requirements of the Zoning Administrator the Sylmar Neighborhood Council voted at their January 27th, 2022 public board meeting to support the applicants desire for improvements and use of the currently vacant restaurant.





belonged to a religious group called the Quakers. Members believed that men and women were equals.

Like a growing number of women, Paul's mom thought that women deserved suffrage, or the right to vote. She took Paul to meetings where women talked about how to win this right. These meetings inspired Paul.

After college, Paul joined the fight for suffrage and became one of its leaders. She gave speeches and wrote to lawmakers. In 1913, she led a parade in Washington, D.C. Thousands of women marched to demand suffrage. Angry onlookers yelled, but the marchers didn't stop.



Winning the Vote

In 1917, Paul dared to do something no one had done before. She led a big protest outside the White House. For eight hours a day, women stood outside the president's home, holding signs.

Police began to arrest the women. Although they were standing quietly on the sidewalk, the women were charged with blocking traffic. Paul was thrown in a dirty jail cell. She was served food crawling with bugs.

All the women were released after a few weeks. But they could no longer be ignored. Feeling pressured,

Women created the Justice Bell to stand for their rights. It looked like the Liberty Bell, a symbol of freedom. This poster shows a woman ringing the bell. What message does it send? What would you draw or write on a suffrage poster?

President Woodrow Wilson said he'd support suffrage.

The 19th Amendment to the U.S. Constitution was finally approved in 1920, one hundred years ago. It gave all women in the U.S. the right to vote.




