- 7. Presentation and Discussion: San Fernando Valley Partnership, Let's Make a Difference Rx Prevention & Alcohol Delivery Projects The goal of these projects is to reduce the likelihood of youth accessing and misusing both alcohol and opioids/prescription medications. 1. The "Let's Make a Difference" campaign works to address to number one source of access to opioids and prescription medications by promoting "safe medication practices" (safe storage, not sharing and proper disposal of all unused or expired medications); and 2. The Alcohol Delivery Project, based on our initial "Merchant Committed" project, works with local retailers to reduce the likelihood of youth accessing alcohol via delivery and prevent possible citations for sales to minors. - **8.** Discussion and Possible Action: 13076 Glenoaks Blvd. Los Mariscos de Sylmar Continued Discussion from last meeting. Various concerns were raised at last Month's meeting including:
  - Monday Thursday Live Entertainment until 12:30am five nights a week Wednesday, Thursday, Friday, Saturday and Sunday Considering restricting hours Su-Th. and mitigate noise to surrounding areas.
  - Sale of Alcohol from 7am to 12:30am daily. Considering restricting hours Su-Th.
  - Maximum 2 outside Events. Was this weekly, monthly or annually? Considering restricting to only a couple of times a year and restricting hours to mitigate noise to surrounding areas.
  - Providing parking lot security during operating hours and close off parking area when business is closed.
  - Shield outside lighting from adjoining properties.
  - There is concern that this would become more of a night-club than a restaurant.

This is a past proposal with changes for enclosing front patio, renewal of live entertainment permit, addition of 500 square foot patio at rear of building for dining, as well as addition of dance floor to center area of restaurant and extending parking area on currently vacant land at rear. Previous hearing date postponed by request of SNC PLUC. Dan Rosales presents and clarifies

previously posed question from owners and planner. Owner/planner states desire to host only 3 large outdoor events a year. Still looking for live entertainment and/or dancing permit 5 nights a week, with enforcement of city sound codes already in place. All other previously presented requests remain as previously presented.

Patty moves to right letter of approval with for application with stated provisions of –

Limit hours of alcohol sales from 10am-12:30am.

Limit large live entertainment/dance nights to 3 a week.

Parking security during any live music & dance events & making sure that parking lot is closed and locked during off hours.

Limit of the previously stated 3 large outdoor events a year.

Request for additional sound buffering for entrances to reduce noise going out into neighborhood.

Bart Trevion questions the available parking provided by the building for residents and guests, since there is recent history of parking being shorted for new buildings within the community. Patty & Peter raises concerns over parking and the shown proposed colors of buildings and designs to fit with the aesthetic of Sylmar of a more Mediterranean/Spanish style with a more natural coloring.
