Applicant representative update on reaching out to the LAPD, Senator Hertzberg's office, and affected and neighboring businesses, to advise them.

LADOT will require driveway closure (two driveways) on Foothill Blvd. for the Shell gas station and business strip mall located at the corner of Foothill and Hubbard, along with a lane closure and suspension of street parking along Foothill near the Reservoir property. That means customers and employees of those businesses will have to use the two driveways along Hubbard to access that property and those businesses, and traffic near that intersection will be impacted to an extent.
