7. Discussion and Information on 15200 Bledsoe at San Fernando Road - Sylmar Studios CEO Tony Guanci and Executive Vice President Scott Hodgkins. Architect Nouizi, ILyes M, inouizi@waremalcomb.com. A new 3-Story concrete tilt-up bldg. w/steel frame construction that consists of 3 continuous fire walls separate the bldg. into 3 buildings, 1-story portion fire wall separate into 2 fire areas to be used as sound stage studios. 3-story fire area portion to be used as office building. Type III-B core and shell only, T.I. shall be comply to code required for each use.

Required parking is are located in the parking structure under permit # 20010-10k-01637. Parking is comprised of a new 6-level cast-in-place concrete, open parking structure with post-production and restaurant space, core & shell only for post-production area and restaurant.

Cheri, started getting phone calls after article and news clipped aired.

Jay, project with help jump start Sylmar and is very supportive.

Peter, run news reel. Work to get more information on the 26-acre project.

Juan Solorio, power point presentation. Lorena Matos is Project Manager, Architect and Burro Manager with Dept. of Sanitation. Channel not well maintained. Efforts made to clean up the Channel, seeking funds to improve the Channel from Measure W group. Seeking support from PLUC. Questions and comments:

Patty Hug, met with group and requested equestrian trails not shown in plans. Horses will use pedestrian walk way. This is a horse area.

Lorena, not enough room in the existing channel width. Channel needs to maintain the same volume of water.

Jay Palmer, document listing project costs. No funding to clean up Sylmar in CD7 budget. Only a 4-block area, cost is very high. Not sure who benefits from this project. Starts and ends nowhere. 100 ways to better ways to spend this money to clean up Sylmar.

Diana, 100% agrees with Jay.

Shirly Granger, read statement. Lives at top end of the Channel Project. Easement to City only for water passage signed 7-11-1950 with City responsible for cleanup. Easement is not for people or horses. Petition signed by residents who lives on the Channel for clean up in 2019. Opposes public access as it will invade back yard privacy and security. Homeless, drugs, night access activities, trespass and other negative impacts like more trash. City has not kept the Channel clean and will not in the future. No public outreach by City. Neighbors do not support public access, ok with clean up and wells.

Tom, agree that easement is for water. Existing fencing is in disrepair and transparent where you can see into back yards.

Bonnie Bernard, appreciated the comments. Worried it will be passed with public access which is just unconceivable.

Jay Santos, lives on the Channel. Same comments as Shirly. Agreed no outreach, was not contacted.

Cheri, massive flooding that happens at Glenoaks and Cobalt, it is almost unpassable will the Channel Project deal with this issue.

Lorena, study not complete. At this moment does not have the full design to be able to address this issue.

Leah Blose, this is the 3<sup>rd</sup> time she has seen this presentation. Believes they have taken the worst of all the designs presented, have not taken any of the Community comments and put them into the design. Just held the meeting to say they did outreach, then did what they wanted. Like putting a concrete top above the channel, not done which would have allowed a horse trail.

Penelope McMillian, channel goes to Bradly and Polk. Effort is only for ½ the Channel.

Lorena, other areas are already channelized. They proposal is only for the natural area to maximize infiltration.

Tom, do you intend to hold further meetings now that local residents are aware.

Lorena, presented August of last year. Yes, they are looking input. Do plan to have further meeting.

Juan, Community engagement will be included in the application.

Peter, summarizes project benefits and community concerns.

Juan, we do want investment and amenities in the community. Try to mitigate impacts. Looking at channel for 2 years, see an opportunity. If we receive the grant we will have more community input during the design phase and revisiting the homes in this area.

Shirly aka "dicelady'1", Do not have proper storm basins at Borden and Rosario which is why the intersection floods. Repeats that easement is not for public access, only water. Juan, met with Shirly for about 1hr, and some if the items can't answer until the funding is awarded.

Anthony Sanchez, asked how they will allocate the funds. Use at Ryan and Herrick to upgrade the pathway and gets flooded.

Juan, funds has specific uses and cannot be used for other reasons.

Peter, thanks everyone.
